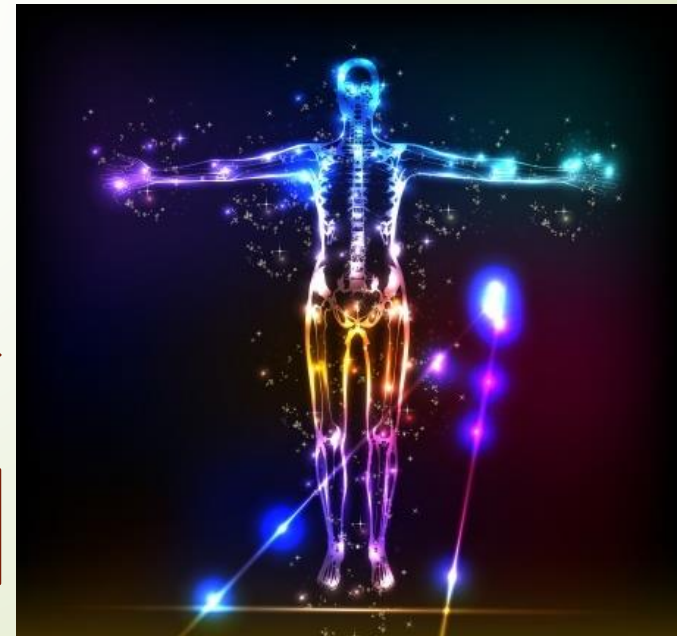

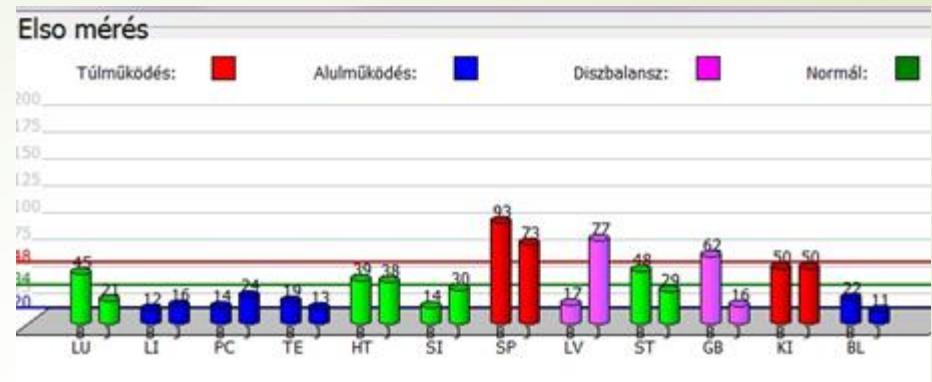

## The main principle

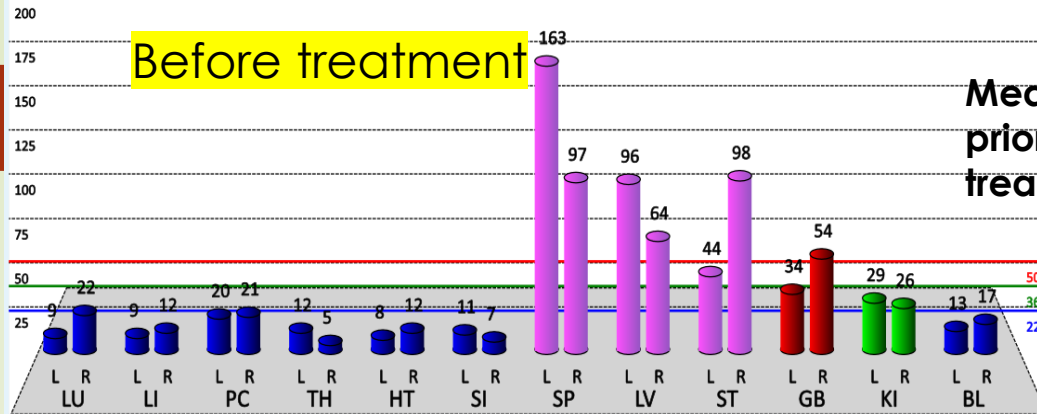

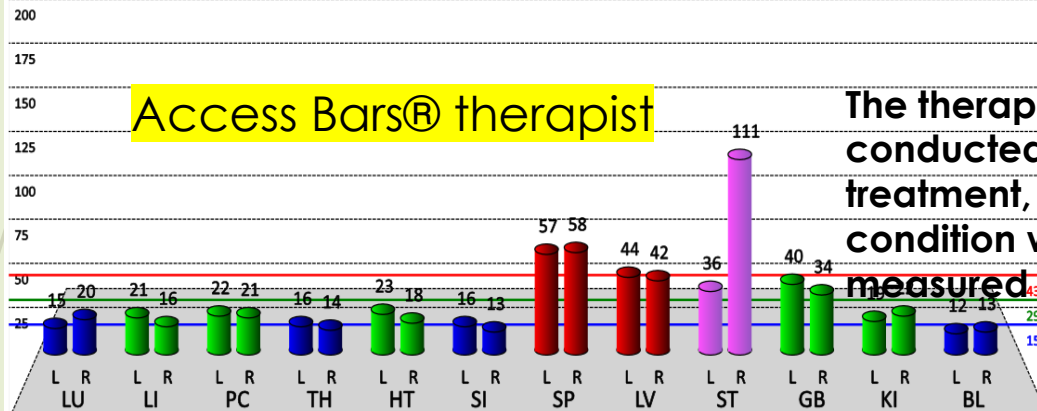

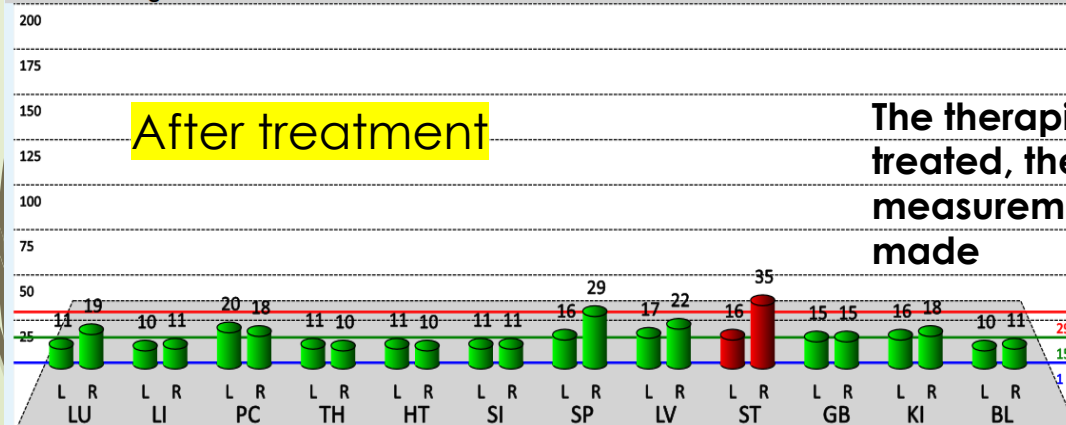

# SUMMARY

Results of initial tests show that by using Access Bars®:

- changes are also triggered towards balance in the meridians of the person conducting the treatment.
- it is apparent in both cases that when the attendants were treated, with the exception of one or two meridians, all their meridians became green, that is, balance was restored.



# CONCLUSION

By using the MeriDiM® instrument we can demonstrate the condition of the meridians as an image. It became possible to monitor the initial, starting conditions of the meridians as well as to compare the condition of the persons conducting the treatment and those treated.

All this is done in an objective manner: the MeriDiM® health assessment instrument measures skin conductivity of the end-point system used in Traditional Chinese Medicine (TCM) (that is, 24 points per person) with 12 V measuring voltage – compared to neutral electrode – between 1 and 200 in  $\mu\text{A}$ . ( $I=U/R$ )

Presenting the effects of the Bars® treatment as an image, it may be concluded that comparative tests should be conducted on a bigger sample. Furthermore, the person performing the MeriDiM® meridian diagnostics should also be measured to find out whether or not in the common space the status or condition of their meridians also change.
